**V. NEW BUSINESS:**

**A. PC18-488FSI, Final Site Plan, Ballenger Creek Center PND, Lot 2C**

The Applicant is requesting final site plan approval for the construction of a 4,000 square foot trucking office, storage, and repair shop on Lot 2C located

within the Ballenger Creek Center Planned Neighborhood Development off Ballenger Creek Center Drive.

The Applicant is also requesting a modification to Section 605 of the Land Management Code (LMC), entitled *Landscaping Standards*. **(NAC #10)(Butler)**

**B. PC18-475PFCP, Preliminary Forest Conservation Plan, Rock Creek Stream Restoration**

The City is requesting approval of a preliminary forest conservation plan in order to plant 0.30 acres of forest in Waterford Park. **(NAC #5)(Reppert)**

**C. PC18-401PSU, Preliminary Plat, Belle Air**

The Applicant is requesting approval for revisions to the previously approved preliminary plat for the Belle Air Planned Neighborhood Development (PND) located on the west side of Baughman's Lane. **(NAC #5)(Reppert)**

**D. PC18-479ZMA, Zoning Map Amendment, 401 Linden Avenue**

The Applicant is requesting a recommendation from the Planning Commission to the Mayor and Board of Aldermen for the rezoning of approximately 13 acres on Linden Avenue from Low Density Residential, R6, to High Density Residential, R16. **(NAC #8)(Brown/Collard)**

**E. PC18-487ZTA, Text Amendment, Section 404, Professional Business (PB) Zoning District**

The Applicant is requesting a recommendation from the Planning Commission to the Mayor and Board of Aldermen for amendments to the following sections of the Land Management Code (LMC) as they generally relate to the Professional Business (PB) zoning district: 401, *Establishment and Purposes of Zoning Districts*, 404, *Use Regulations*, 805, *Adult Day Care*, 832, *Indoor Sports Complex*, 839, *Multifamily in PB Zone*, 841, *Nursing Home/Domiciliary Care/Adult Living Facility*, and 861, *Senior Living and Retirement Facilities*. **(Collard)**

**F. PC15-701ZTA, Text Amendment, Section 404, Table 404-1, Medical Cannabis**

The City is requesting a recommendation from the Planning Commission to the Mayor and Board of Alderman for amendments to Section 404 of the Land Management Code entitled, *Use Regulations*, Section 607, *Parking and Loading Standards*, and Section 1002, *Definitions* in order to establish the use of a medical cannabis dispensary.
